RELEASE AND WAIVER OF LIABILITY AGREEMENT

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN MYSELF AND THE RACING DOG RESCUE PROJECT, INC., THE STATE, THE COUNTY, THE LESSOR, AND SIGN IT OF MY OWN FREE WILL.
